On March 25, 2010, representatives from the Alliance for Telecommunications Industry Solutions (ATIS) and its Ordering and Billing Forum (OBF) had a telephone conversation with representatives from the Competition Policy Division of the Wireline Competition Bureau (WCB/CPD).

During the conversation, ATIS provided an update on the work of its SMS/800 Number Administration Committee (SNAC) to implement proposed changes to the Toll Free Service Guidelines to reduce inadvertent porting.

Also discussed was the industry proposal regarding number portability developed by the OBF and recommended for approval by the North American Numbering Council's Local Number Portability Administration Working Group. ATIS explained that, in order to comply with the FCC's established porting interval for simple ports, the industry proposal excludes from the simple porting process those port orders made in conjunction with a directory listing change.

The following representatives from the WCB/CPB were present at the meeting: Ann Stevens, Deputy Chief; Heather Hendrickson, Attorney Advisor; Michelle Sclater, Attorney Advisor; Melissa Droller Kirkel, Attorney Advisor; and Marilyn Jones, Attorney Advisor.
